ADOPTION CONTRACT

This Adoption Contract is made, and hereby entered into, on this ____ day of _____ 200__ by and between Michigan Siamese Rescue, (hereinafter referred to as “MISR”) and _____ (hereinafter referred to as “Adopter”) for the purpose of setting forth the terms and conditions of placing the following feline(s), identified as _____.

By my signature below, I, the Adopter, agree that the feline(s) will reside in my home and will not be allowed out of doors unless on a harness and supervised at all times. I agree that the feline(s) will not be left unattended for a period in excess of 10 hours and will always have fresh food and water available as well as clean litter boxes.

I understand that, at any time, that I am unable to keep the feline(s) identified above and it becomes necessary to relinquish or otherwise place subject pets, MISR retains **FULL AND NONNEGOTIABLE RIGHTS OF FIRST REFUSAL** and MISR **agrees that they will either accept the feline(s) back into the rescue or assist in the rehoming of said feline(s).** I agree that I am personally responsible for returning the identified feline(s) to MISR.

I agree that **a copy of this Contract will be provided to a friend or relative (not living with me) within 5 days** of this date for the signature of said friend or relative, confirming their understanding that the subject feline(s) are to be returned to MISR in the unlikely event that Adopter becomes incapacitated and is unable to provide the care required by this Contract. The signed Contract will be returned to MISR for placement in their permanent adoption records.

I understand that any donation given by the undersigned is a wholly voluntary gift and is in no sense to be regarded as a return for value received. Donations are not refundable.

I agree to provide licensed veterinary care for the subject feline(s) including the administration of their next scheduled booster vaccine due on approximately _____. In addition, I agree to maintain preventative health care of subject feline(s) including, but not limited to: annual general physical examination, vaccinations as required, and control of any internal as well as external parasites. It is

agreed that I will provide MISR with a copy of the vaccine record for the first annual booster vaccine as a confirmation that the feline(s) are receiving all regularly scheduled vaccines. Failure to produce such vaccine records within 10 days of the date that boosters are due shall result in MISR having the right to void this Contract and accept subject feline(s) back into the rescue program. I also agree that the subject feline(s) will receive immediate medical treatment by a licensed veterinarian when they become ill or injured.

I agree to maintain the general health care of subject feline(s) in regards to wholesome food, clean, fresh water and clean litter boxes. In the event that the feline(s) require special care these requirements will be listed in an attached Appendix. I agree to abide by all care provisions that may be outlined in such an Appendix and assume all costs associated with providing such care. I also agree that a minimum of one litter box per cat in household plus one additional litter box will be provided, said litter boxes to be spaced at various locations throughout the household to ensure that all feline(s) in the household will have easy access to litter boxes as needed.

I further agree that if subject feline(s) become lost, every reasonable effort will be made to recover the feline(s), including but not limited to, advertising at the expense of the Adopter in local newspapers, visiting the local animal shelters and paying all recovery fees if the animals are seized by animal control officers. I agree to notify MISR within 24 hours if the feline(s) are missing so that they may assist in the recovery efforts.

I agree that the feline(s) will wear a name tag at all times and will never be transported except within an approved feline carrier. I further agree that the feline(s) will be licensed with the appropriate city/county/township of Adopter's residence as required by law.

I understand and agree that MISR retains the right to know the whereabouts of subject feline(s) for the duration of their lives and therefore agree to provide MISR with my new telephone number and/or address within 5 days of any changes.

I will permit MISR to inspect the feline(s) and premises that the feline(s) reside at, at any time. If, in the opinion of MISR, the feline(s) are being improperly cared for, I understand and agree that MISR will take immediate possession of the animal at no expense to MISR. I agree to immediately surrender the feline(s) peaceably and voluntarily and will thereafter surrender all claims of any kind or nature of said feline(s) or against MISR.

I understand that MISR does not make any guarantee or warranty as to the health of the subject feline(s) and is not responsible for any medical expenses which may be incurred in respect to subject feline(s). I agree that the subject feline(s) have been received without any warranties or guarantees, express or implied, about the feline(s) condition, behavior or prior ownership. Therefore, I hereby release and discharge MISR forever from liability for any injury or damages to any person or property
