I hereby acknowledge receipt of _____ (animal's name),

I, _____ (your name), agree to the following:

1. I will provide adequate food, water, shelter, and grooming for the animal at all times.
2. I will provide a safe fenced in area for the animal to exercise in and/or I will walk the animal on leash for adequate exercise.
3. I will provide necessary emergency veterinary treatment, annual veterinary check-ups, ensure that the animal is always current on vaccines, and provide year round heartworm prevention.
4. I will obey local and state laws regarding rabies vaccines, sterilization, and animal control.
5. I will provide proper ID tags on a collar for the animal.
6. I will never allow this animal to ride in an open bed of any vehicle without the proper restraint of a secured pet carrier.
7. I will not sell, give away, or abandon the animal at any time. If I am no longer able to provide the animal with a good home, I will return it to MBR.
8. I will make a donation of to MBR to offset the costs of medical treatment, spaying/neutering, vaccinations, training, transportation, and boarding fees. A more substantial donation may be required for animals with greater medical expenses. 9. If the animal is not already sterilized, I agree to have the animal sterilized by a licensed veterinarian within _____ days or I will return the animal to MBR.
10. If the said animal is under the age of 5 years, I will attend age appropriate group obedience classes at Good Dog University (GDU) to socialize and train the animal and ensure that I have proper control over the animal. I understand that there will be no charge for these group classes. If for any reason I am unable to attend group classes, I will arrange for private lessons at GDU or by another trainer approved by MBR at my expense or return the animal to MBR.

I, _____ (your name), also understand that:

1. MBR makes NO claims or representations as to the temperament, health, or mental disposition of the animal. I accept the animal "as is" and MBR or its representatives are not responsible for any future health or temperament issues the animal may develop.
2. I do hereby release, remise, and forever discharge MBR, any persons, or entities related hereto, together with their agents, officers, officials, directors and employees (said corporations, entities, and individuals hereinafter referred to as "Releasees") from any and all liabilities, claims, demands, or causes of action whatsoever arising out of, or related to, any injury, loss, or damage sustained or suffered by me or any third party by the animal. If I am injured, I agree that I will not sue or otherwise hold responsible said Releasees. I am aware that animals may be hazardous or expose me to hazards, and I do freely and voluntarily assume all of the risks, known or unknown, incidental to my adoption of this animal.
3. If I am unable to keep the animal for any reason, I must return it to MBR. I understand that a refund of fees will only be given within the first two weeks of adoption.
